7. Proceeding to Referendum

General Background-

The Independent Examiner's report had been published and was available on the SSDC website. SSDC Strategic Planning, will now take the report to SSDC's District Executive Committee on 7th July to seek approval to go to referendum

SSDC Strategic Planning advised that:

If approval is given, SSDC will publish a Decision Notice on its web site and the Elections Team will be notified. They will set a date and make the arrangements for the referendum.

The referendum has to be within 56 working days / 11 weeks of the decision to proceed to referendum. Dates will be confirmed once arrangements have been made. Initial discussions with the Electoral Services Team indicate that the referendum is likely be held in early September.

An Information Statement must be published no fewer than 28 days before the date the referendum is to be held (not including weekends, bank holidays, days of public thanksgiving) and is the start of the 'referendum period'.
